A pine tree-lined blacktop drive leads through the property to the secluded residence, horse barn, and additional outbuilding. Recent extensive grounds work has restored trails throughout the property and into the rear acreage, opened views and access to the spring-fed ponds, cleared pasture, and revealed the remarkable scale and versatility of the land. And there are no covenants or restrictions (other than county and municipal codes and zoning laws) to restrict what you see fit to do with this property, which gives the next homeowner unprecedented freedom and flexibility in its use.
